Who we are

Information we gather

We only collect data required by us to undertake any tasks on your behalf. This information is stored on databases located on our secure server. Only authorised employees of Sherwill Drake Forbes have access to these databases and, where permitted, make any alterations to the data held on that database.

The information we collect includes:

- Address
- Landline and/or Mobile Number
- E-mail address.

We collect your personal information from:

- a) Authority To Act Form;
- b) Any information entered on our website;
- Email, post, fax and mail correspondence with Sherwill Drake Forbes; and
- d) Contact via phone.

We will use this information to:

What is the legal basis for processing your data
